Dear patients,

Dear parents and accompaniment of our child patients,

the CORONA-Virus continues to influence our everyday hospital life. Therefore, we would like to give you information about our current regulations below.

We ask for your attention!

<u>General hygiene rules</u>

Mouth and nose protection is mandatory in the entire hospital building.

From December 21, 2020, **visitors** must also wear an **FFP2 mask** during their entire stay in the clinic.

To be noted in general	Hand washing and disinfection is important
Keep the greatest possible distance when	On arrival at the hospital.
coughing or sneezing - it is best to turn away.	 After blowing your nose, sneezing or coughing.
• Sneeze into the crook of your arm or into a tissue that you throw away.	Before food preparation and before eating.
• Avoid contact when greeting other people.	After using the toilet.
• Wash your hands regularly and thoroughly with soap and water for at least 20 seconds.	
• Keep your hands away from your face and avoid touching your mouth, eyes, or nose.	

On the day of inpatient admission

Please only arrive if you are healthy!

If you are unsure, please contact the patient admission department in advance on 08052/171 0!

- You pass the screening station and then go to the admission for administrative admission. Then go to the ward assigned to you and contact the nursing staff.
- Patients and accompanying persons who may be admitted to the hospital receive a PoC antigen quick test and are tested for SARS-CoV-2.
- Our care team coordinates the further admission processes and informs you accordingly.

Physiotherapy and occupational therapy

With a few exceptions, physiotherapy and occupational therapy take place in the patient's room. We ask that parents who are not involved in the therapy (e.g., parents of a fellow patient in the same room) leave the room upon request by the therapist in order to keep the number of people in the room as low as possible.

Orthopedic technology

Scans for orthotics as well as orthotic fittings take place in the room with a few exceptions.

Meals: Buffet with mouth and nose protection (ffp2 mask) compulsory

As usual, all meals are offered in buffet form. In order to avoid queuing, the nursing staff will inform you when you can come to the buffet. <u>Mouth / nose protection is mandatory</u>. Gloves and disinfectants are also available in front of the dining room.

Schlawinertreff

We have also adapted the offer of our "Schlawinertreff" to the current situation. The Schlawinertreff currently visits the children in the rooms and has offers ready that can be tinkered, painted or played in the rooms.

Smoking area

Smokers are allowed to leave the house with face masks and smoke in the designated area on the clinic premises ("bus shelter").

Please note that smoking on the rest of the Clinic ground including in front of the entrance is forbidden.

Shopping service

To support you, we offer a shopping service with the local Edeka store. You can get more detailed information about the ordering process and the service process on the information board of your ward.

Important appeal and urgent request:

Do not leave the clinic during your stay!

We want to make the shelter within the clinic as safe as possible, especially for our child patient and patients! We therefore urgently ask you <u>not to leave the clinic</u> during your stay <u>in order to protect against</u> <u>infection</u>!



Visitor regulation

taking into account the requirements of infection protection

1.7.2021

Our protection and hygiene concept must be adhered to.

This includes wearing mouth / nose protection (ffp2-mask) within the clinic, as well as maintaining the minimum distance of 1.5 meters!

The instructions of our employees are binding!

In detail, the following visitor regulations apply to our house:

- One visitor per patient may be received daily, even if an accompanying person is included.
- Patients over 18 years of age, the accompanying person also counts as the visitor.
- Visitors must wear an FFP2 mask at all times (including in the patient room)
- With regard to an infection with SARS-CoV -2, visitors must present a negative PoC antigen rapid test or a negative PCR test no older than 48 hours. In this regard, it is possible to be tested on the relevant station.
- If you show proof of a complete vaccination against COVID-19 or proof of recovery from the disease when entering the clinic no test additionally is needed.
- Due to the entry ban for children and young people under the age of 16, visits by (sibling) children are unfortunately still not allowed.
- There are no fixed visiting times. However, the clinic may only be entered once a day before 5:00 p.m. in order to pass the screening station and have the documentary data recorded. Please then register with the nurses on the ward before entering the room and sign out when you leave the hospital.
- Mouth and nose protection (ffp2-mask) is mandatory within the clinic, including in the patient room!
- The visit is received in the patient's room respecting the max. amount of persons allowed in one room.
- It should be noted that no more than five people are in a patient room.
- Visitors who have had signs of a respiratory illness or a feverish infection in the last 14 days as well as people who have had contact with a SARS-CoV2 virus (coronavirus) and / or a suspected case in the last 14 days or who have had contact in the last 14 days in a risk area (according to RKI) <u>are not allowed to enter the clinic!</u>
